DRAFT PRECEPT/BUDGET - Proposed expenditure sheet distributed to all councillors

Owing to possible financial cut backs on local services, which are not known just yet, HALC is recommending that parish councils wait to hear how their parishes may be affected before finalizing their precept for 2011/12. HALC says there could also be a need for any loss of service provision to be regained by a few parish councils joining together for this purpose. The following is a comment e mailed out to all parish councils by the Parish Liaison and Rural Services Officer at H. Council:

"A number of other parish/town councils have expressed concern over their meeting the 31 December 2010 deadline for the return of the Precept Form. The Precept Forms need to be submitted in good time to enable the information to be included in the council tax leaflet and the council tax bills.

However, following feedback from some parish and town councils, the council has reviewed the deadline given to parish/town councils and is pleased to be able to extend this to 31 January 2011."

HALC has also advised that there will be a meeting for Clerks and Chairpersons on 26th January to discuss the implications of any cuts in services, and that Councils may then discuss the points raised there, with their Councillors. Provided that Councils advise H. Council afterwards of their intention to finalise their Precept requirement shortly afterwards, and submit their requirement by the end of February, this will by allowed.

On this basis it was agreed that the Vice Chairman and the Clerk will attend the 26th January meeting, and a special meeting of the Parish Council to finalise its Precept will be held on 2nd February.

D161 Village Green Work & Expenditure Report - Cllr. Myers

- 1) Works for both winter and spring need to be undertaken on the conservation area, with some concerns as to whether the area should be left looking 'natural and wild' or trimmed. - 2) Mowing of the village green will continue twice, and cutting grass 6 times around the car park and by the riverside. No changes required to this arrangement.
- 3) Three trees on the green are diseased and need to be felled.
