G101 Pride in Pembridge Group – Cllr. A. Stokes – Update on “In Bloom” Competition & Damage to Children’s Playground Surface (combined)

On 4th July the Heart of England In Bloom judging day took place here; the result will be declared at Drayton Manor Park on 12th September 2013.

On 16th July a Briefing Meeting took place for the final judging day on 31st July, and advice was given on areas needing improving and tidying up. A road sweep will be requested.

The Children’s playground wet pour surface has been vandalised in two areas near the swings. In readiness for this meeting, a quotation has been received from one specialist company for the repairs.

Option 1 was to repair patch both areas for the sum of £675.00

Option 2 was for a full overlay of both sets of swings for the sum of £2,064.00

There was a proposal for the Option 2 to be chosen, and with a show of hands, all were in favour.

Cllr. Stokes will arrange for the repair work to be undertaken, but will first obtain a second quotation from an alternative company for cost comparison.

The school Open Day took place last Friday, and there were lots of visitors.

There will be a very busy meeting of Herefordshire Council this Friday, when the Core Strategy will be considered. If passed, it will then Get passed to an Inspector delegated by the Government for their consideration. Without a Neighbourhood Plan being in place, Cllr. Phillips thought that parishes are vulnerable to approaches by developers.

It was pointed out to Cllr. Phillips that there is a dangerous bump in the road on the western end of the A44 in the village. Cllr. Phillips will arrange for this to be attended to.
