### The Chairman requested that the order of the Agenda be altered, as follows:

# **Guest Speaker – Dave Chillery, Logistics Manager, Kingspan:**

The speaker outlined his role as Logistics Manager, and invited questions from the councillors. There was then general discussion relating to recent HGV traffic incidents that had occurred in the village, and the fact that drivers delivering to and from Kingspan still do not all seem to be aware of the correct route in and out of the site.

It was explained that very good information and maps are given to all haulage companies by Kingspan (samples were shown), and Dave needed to be made aware of which companies are not complying with the information. He requested that in future, if details of registration numbers and names of haulage firms could be provided to Kingspan that they would follow this up, with the aim of reducing such incidences. #### H120 Speed Indicator Device - Proposal to share with Shobdon & Titley Parish Councils -Chairman:

The price charged on each occasion by H. Council to deploy a Speed Indicator Device in the village is now £195.00 + VAT.

Shobdon Parish Council owns its own S.I.D. and has asked both Pembridge and Titley Parish Councils to join with them in sharing it, with a ring-fenced sum each of £100 per month being collected. For both running and maintenance costs.

The Parish Council will now consider alternative ways of provision of a Speed Indicator Device.

#### H121 Glass Recycling Bins Site Improvement - Cllr. A. Pace:

4 weeks ago when the bins were emptied, they were inspected beforehand, and no trade waste was seen.
