115/16. Update on the Neighbourhood Development Planning.

116/16. Lengthsman & Footpaths Scheme 2017/18.

The Clerk advised councillors of the changes to the lengthsman and P3 scheme for 2017/18. The Parish Council makes mandatory contributions of 66% to receive 33% grant funding. The grant funding available has reduced from £120/Km to £30/Km. The P3 grant continues at £15/Km. Both grants will reduce to zero by 2020. Councillors **agreed** to continue the Lengthsman and P3 scheme for 2017/18 paying the mandatory contributions and any budget shortfall required from the precept. To review in future years.

117/16. 20mph Speed Limit in the Village.

Cllr Rogers contacted Pershore Parish Council, where the County Council helped fund their enhanced scheme. There is lack of money available in Herefordshire for Traffic Regulation Orders and parishes are able to contribute to speed up the process. The estimated cost to install signage through the village would be in the region of £4000. There may be funds available from the recent application at East Street (S278 money). Councillors **Agreed** to pursue introduction of a 20mph speed limit and decided to meet with Ray Wallace from Herefordshire Council to discuss options available. *Clerk to arrange meeting*.
