The group then received full verbal presentations from the above members who had consulted in the community to produce their objective detail. All agreed initial work on these objectives had produced good points to start working on. Objective information is still outstanding from the environment team in their absence.

Some members would like to see faster progression and it was agreed to develop the objectives fully. Team members were asked to elaborate and complete a more comprehensive and completed set of objectives for discussion before the next meeting.

### 4. A.O.B

Cllr Pace provided members with details of land available in the parish. Location information is withheld at present as previously agreed. The group discussed the land available for housing and business opportunities and were confident (if owner prepared to and planning acquired) of fulfilling the 44 houses requirement by 2031.

Cllr Pace advised the recent Parish Council response to Eardisland NDP Reg 14 consultation that Pembridge would not be able to cater for their shortfall.
